



**Job Title:** Specialty Box and Lid Builder

**SUMMARY OF JOB PURPOSE:** Build Concrete Box Culverts and lids to meet company specifications

**ESSENTIAL FUNCTIONS AND MAJOR RESPONSIBILITIES:**

- Have working knowledge of Symon panels.
- Read blueprints to determine box and cage dimensions.
- Snap Chalk lines at desired measurements and use cross-tape method to ensure box and cages are square.
- Build a rebar cage by tying together rebar and spacers using a rebar tying tool.
- Install lifters as required and work with crane operators to safely move items in the yard.
- Set rebar cages on the cores and prep for concrete.
- Place Styrofoam or wood as needed in lid forms.
- Pour concrete in forms may require raking or shoveling.
- Remove forms, clean and prepare for next use.
- Once all items are removed, clean up box or lid of any loose concrete.

- Support the rest of the production team.
- Maintain a clean and safe work area.

**KNOWLEDGE, SKILLS, ABILITIES:**

- Ability to read and interpret blue prints.
- Must be able to accurately read tape measure and follow through to the products for accuracy.
- Confident in using tools such drills, impact driver, skill saw and table saw.

**EDUCATION/EXPERIENCE:**

- A minimum of 2+ years of experience in rough, concrete, carpentry and pouring concrete or equivalent combination of education and experience.
