JOB SUMMARY

The Cement Finisher is primarily responsible for prepping pipe, operating gunite machine and cement finishing of pipe in the coating and lining department.

PRIMARY RESPONSIBILITIES

- Applies gunite to pipe by machine and hand application
- Operate gunite machine / hose
- Finish cement
- Inspect pipe before and after pipe is coated and or lined
- Prepares pipe for coating
- Cleans and inspects machines

ADDITIONAL RESPONSIBILITIES

- Operates tape coat, coal tar, blaster, coater, and liner machine and related equipment
- Applies various types of coatings to pipe by machine and hand application
- Loads and unloads product in to specific machines
- Perform preventative maintenance on machines
- Operate forklift and skip loader
- Other duties may be assigned as necessary

- Must be skilled in cement finishing

- Must be skilled to apply a variety of coating/lining finishes by machine and hand application
- Reading gauges and watching guides
- Ability to read drawings to determine correct coating/lining to be applied to pipe
- Ability to obtain and maintain forklift certification if required
- Able to operate skip loader/grader equipment
- Ability to use hand held radios for communicating

EDUCATION / EXPERIENCE / CERTIFICATES, LICENSES, REGISTRATIONS

- Prefer minimum two years experience in a heavy manufacturing environment
- Prefer minimum two years experience with guniting machine / hose and or cement finishing
- Prefer minimum one year experience with coating/lining operation and application experience on steel pipe
- Prefer minimum two years experience reading drawings
- Basic mathematics skills

WORK ENVIRONMENT

- The environmental conditions for this position include inclement outdoor extremes of cold, heat, dust, wind and various forms of precipitation.
- Walking, moving around and or standing eight (8) hours or more per day. Walking includes moving within a 100 acre facility with dirt roads and uneven ground.
- Recurring climbing and descending of stairs throughout the day to perform work at heights. Work for this position can be performed at an elevated station and requires a comfort with heights and balance.
- A minimum amount of sitting may be required for this position.
- There is repetitive hand-wrist, elbow and shoulder motion required for this position for approximately eight (8) hours during the work day.
- Lifting and or retrieving items of 0-50 pounds without assistance; 50 – 100 pounds with assistance and 100+ pounds with mechanical assistance.
- While operating a forklift or skip loader must be able to press clutch, brake and gas pedals and the ability to control equipment with mechanical hand levers.
- In the course of a normal day additional physical activities include bending, stooping, squatting, kneeling, crawling, pushing, pulling, twisting, reaching and climbing ladders.
- Employees in this position are exposed to a wide range of varying degree of moderate to excessive noise levels.
- Sight must be within normal ranges to determine that machines are running properly. Specific vision abilities also include close, distance, color, peripheral, depth and the ability to adjust and focus.
- Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.
