- Must be able to kneel, squat, crawl or stand for extended periods of time inside a pipe
- Able to work at heights
- Skilled in fitting-up steel pieces in welding fixtures and jigs. Ensures proper alignment and dimensional specifications are held.
- Weld or tack parts into various sub-assemblies or complete assemblies
- Experience using an Overhead Crane to move product from one location to another.
- Knowledgeable of welding technology, equipment types, applications and material characteristics.
- Must be able to read a tape measure and properly apply to pipe sizes
- Must be able to use hand grinders and other misc. hand tools
- Team Player with Leadership skills and abilities
- Previous Certifications preferred
